

- Electronic submission of entries. payment of entry fees by credit card, and pdf. format fillable Entry and Waiver forms are now available for exhibitors' convenience. Please see the instructions for directions on how to use these options.
- Credit Card Surcharge: There is a Paypal surcharge for entry fee payments by credit card. See entry form directions for surcharge amounts.
- **AKC Recording Fees:** Per AKC, "A recording fee of \$3.50 will be required for each dog entered If a dog is entered in more than one class, the recording fee will be collected on the first entry only." **The recording fee is included in the trial entry fee**.
- Closing Date: Entries close at 5:00 P.M on Friday, July 30, 2021, after which time entries cannot be accepted, changed or canceled as provided in Chapter 11, Section 6 of the Dog Show Rules. All overnight entries must be marked "Signature Waived." No entry will be accepted, canceled or changed after the closing date. The exception is for bitches that come in season after the closing.
- Transfers (moveups): Transfers for the Saturday, August 7, 2021 trials must be submitted to the Trial Secretary by Monday, August 2, 2021. Transfers for the Sunday, August 8, 2021 trials must be submitted to the Trial Secretary by the close of Saturday's trials. Contact or see the Trial Secretary for transfer forms.

#### **COVID-19 PRECAUTIONS**

- DTCT is committed to holding these trials contingent on compliance with governmental regulations and with cautious regard to everyone's health and safety. We are updating our mask policies and we anticipate an effective date of June 30.
- In the meantime, our current policy of masking inside the DTCT building remains in effect. However, exhibitors may remove their masks while in the ring exhibiting. This is the only exception, and it only applies while the exhibitor is in the ring and exhibiting. Masks must be worn at all other times.
- The closing date has also been extended to allow potential exhibitors additional decision time as to whether to participate. If you do decide to attend, you will be asked to submit and sign the DTCT Event Waiver and Agreement which includes COVID-19 provisions. No entries will be accepted without the signed waiver. The waiver is found after the entry blank included in this Premium.

Should any trial need to be canceled due to COVID-19, please be assured that you will receive a 100% refund of your actual entry fees. Mailed
entries will have checks shredded, and those using Paypal online entries will receive a full entry fee credit to your credit card minus Paypal
transaction fees. Checks will not be deposited until after the trial closing date.

#### TRIAL SITE

- There is no room for RV's on the trial site. Overnight parking is NOT allowed.
- The building will be air conditioned for the dogs' comfort.
- Food and drinks will **not** be available for sale on the premises. However, there are many fast-food restaurants close by.
- Dogs should be present not more than ½ hour prior to judging and will be expected to leave immediately after the class unless needed for further judging.
- Due to space constraints, unentered dogs and X-pens are not allowed on the premises during the Trials.

### **RALLY EXHIBITORS**

If your Rally class requires a jump height (because the class will be ordered by jump height) you **MUST** supply a jump height on your entry form or the trial secretary will not accept your entry. The Trial Secretary will not contact you for this information.

- Rally jump heights for Saturday will be 16"- 4" and Sunday, 4"- 16".
- You are expected to understand the Rally Rules and understand which Rally class "A" or "B" at any level to enter. The rules differ between the Rally Novice class. Intermediate and Advanced/Excellent and Master classes. Be advised that your leg will not count if you earn it in the wrong class! Consult the AKC rules for Rally at www.akc.org

#### **HOW TO SEND IN AN ENTRY**

## **Entry Preparation:**

- In the top section of the entry form check the box(es) next to the class(es) you wish to enter in each trial. Enter the jump height in the next column where needed. Then enter the entry fee in the box to the right of the jump height box. Put the total entry fee for each trial at the bottom of the entry fee column. In the bottom row enter the total entry fee for all trials and the Paypal surcharge. Put the total amount submitted in the last box on the right.
- Enter the dog's information and the owner's information in the lower boxes. Be sure to include the **BIRTHDATE**, **REGISTRATION NUMBER**, **the DOG'S OFFICIAL NAME and GENDER**. Sign your name in the signature boxes on both forms.
- If any information is illegible, the entry will not be processed, and the handler will be requested to email the information.

The Agreement form only requires entering the owner's name, telephone number, email address and another signatur **Payment of Entry Fees:** You may pay the entry fees either by check or using a credit card.

- Payment by Check--Checks should be made out to "DTCT" and mailed to the Trial Secretary.
- Payment by Credit Card—If you wish the convenience of using a credit card, you must use your personal Paypal account. Open the account, click the "Send" button, enter "DTCTampa@yahoo.com" in the box and follow the prompts from there. Please indicate in the notes section what the payment is for. There is a surcharge for using the Paypal account. To send amounts under \$30, add \$2; for \$30-\$99 add \$3; for \$100 or over add \$4.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us). I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN THIS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

# EVENT LIABILITY WAIVER & AGREEMENT Dog Training Club of Tampa

**Definitions:** The terms used in this Waiver include:

Dog Training Club of Tampa together with its Officers, Board of Directors, Members and Judges contracted for this event are hereinafter referred to as "DTCT"; Events covered under this waiver include but are not limited to obedience, rally, agility and Barnhunt trials, and educational seminars and workshops, hereinafter referred to as "Event":

**Participants** in events include but are not limited to trial exhibitors and educational seminar or workshop attendees, hereinafter known as "Participants"; **Parent Organizations** under whose auspices this Event is held include but are not limited to the American Kennel Club, the Toy Dog Agility Association, the Barnhunt Association, and the United Kennel Club, hereinafter known as "Parent Organization".

Acknowledgement of Risk: I acknowledge that DTCT's premises, and the animals, guests, items, and activities therein, posedangers to people and animals. Such dangers include, by way of example and not limitation, animals that can bite, trip, knock down, and fight, indoor or outdoor surfaces that may be slippery, equipment that can trip, guests and clients who cannot control their dogs, and activities involving my dog(s) and/or other dogs that can result in injury from bites or other causes.

**Assumption of Risk:** Accordingly, I, on behalf, my spouse and minor children, and anyone else whom I bring onto DTCT's premises for this Event, assume the risk of injuries, losses, damages, costs and expenses by any means above described, and other injuries, losses, damages, costs and expenses by any means above described, and other injuries, losses, damages, costs and expenses of every probable cause and description unless inflicted intentionally or recklessly by DTCT, and people who may not be Members of DTCT, but are volunteering as support personnel for the Event such as Ring Stewards, Table Stewards, Timers, Leash Runners, Course Builders, Scribes and others.

General Liability: If a dog is injured in a dog fight or an accident, gets fleas, ticks, or worms, contracts any illness or disease, is lost or stolen, becomes pregnant, or engages in any dangerous, vicious or unwanted behavior, during or after the term of this agreement, on or off DTCT's premises, I accept the risk of the same and agree that DTCT, shall not be held responsible for it or any resulting injuries, losses, damages, costs or expenses. If any dog I bring to DTCT causes property damage, or bites or injures any dog, animal or person including but not limited to DTCT, during or after the terms of this agreement, on or off DTCT's premises, I agree to hold DTCT harmless, and to pay all resulting losses and damages suffered or incurred by DTCT and to defend and indemnify DTCT from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees.

**COVID-19 Liability:** I attest that to the best of my knowledge, I do not have COVID-19 at the time of attending this event and understand the risks of unknowing exposure to this and other illnesses by or to myself, my family, other participants, and third parties; and do not have symptoms. I agree that I will not knowingly expose others to any illness I may have or be at risk to have. I will follow all Parent Organization and DTCT rules and requirements to reduce any exposure and possibility of contracting or spreading the virus. I will also fully cooperate with and follow any Federal, County or State guidelines that have jurisdiction in the area in which the event is taking place. If any of the above should change prior to my arrival at the trial site or during the completion of the event that is the subject of this consent, I will inform the DTCT and proceed accordingly in light of the new information.

I agree that I am attending this DTCT event entirely at my own risk and assume all risk and full responsibility for my own health, wellbeing, and safety during this class or event. I fully agree that Parent Organization and DTCT are in no way liable for any present or future COVID-19 exposure incurred at any time by any person, in attendance or not in attendance, during or after this event, and I hereby waive and release the Parent Organization and DTCT, from any and all liability for damages thereto.

**Binding Agreement:** This Agreement is binding upon the Participant and supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between the Participant and DTCT, regarding the matters described above. The parties confirm that, except for that which is specifically written in the Agreement, no promises, representations or oral understandings have been made.
