

ENTRY FEES

<u>Mailed entries</u>: \$30 for ALL regular class first entries; \$21 for the second entry of the same dog in the same trial.

<u>Paypal entries:</u> \$33 for ALL regular class first entries; \$24 for the second entry of the same dog in the same trial.

- Payment by Check-- Entry fees may be paid by check. Checks should be made out to "DTCT" and mailed to the Trial Secretary along with the entry form. Checks will be deposited immediately after the trial closing date.
- Paypal Payments: Paypal transaction fees are included in the Paypal entry fee payment options listed above. You must use your personal Paypal account. Open the account, click the "Send" button, enter DTCTampa@yahoo.com in the box and follow the prompts from there. Please indicate in the notes section that the payment is for the February 22-23, 2025 obedience trial entry fees. Proof of payment is required for Paypal online entries to be processed.
- Recording Fees: Per AKC, a recording fee of \$3.50 will be required for each
 dog's first entry in a trial. If the same dog is entered in more classes in the
 same trial, the recording fee will be \$3.00.for each subsequent class. The
 recording fee is included in the trial entryfee.

OTHER INFORMATION

 Closing Date: Entries close at 6:00 P.M on Friday, February 7, 2025, after which time entries cannot be accepted, changed, or cancelled as provided in Chapter 11, Section 6 of the Dog Show Rules. All overnight entries must be marked "Signature Waived." **No entries will be accepted, canceled, or changed after the closing date.** The exception is for bitches that come in season after the closing.

- Transfers (moveups): Transfers for Saturday, February 22, 2025, trials must be submitted to the Trial Secretary by Monday, February 17, 2025. Transfers for the Sunday, February 23, 2025, trials must be submitted to the Trial Secretary by the close of Saturday's trials. Same trial day transfers are not allowed. Contact or see the Trial Secretary for transfer forms.
- Judging Limits—Judging shall be limited to 8 hours per day including bathroom and meal breaks.

TRIAL SITE

- There is no room for RV's on the trial site. Overnight parking is NOT allowed.
- The building will be air conditioned for the comfort of handlers and dogs.
- Food and snacks will be available for a \$5 donation. All monies raised will be used to purchase new obedience and rally equipment.
- Dogs should be present not more than ½ hour prior to judging and will be expected to leave immediately after the class unless needed for further judging.
- Due to space constraints, unentered dogs and X-pens are not allowed on the premises during the Trials.
- Chairs and crates cannot be placed directly on the ring matting. Please bring your own mat if you wish to use the designated crating area.

DESCRIPTION OF WILD CARD R/R CLASSES:

THIS APPLIES TO: R/R NOVICE, R/R OPEN AND R/R UTILITY.

The Random Reward class is for any dog that can perform the exercises in that level class and is eligible under the Obedience Regulations to compete in AKC events. No title is required to enter, and handlers may enter more than one dog. Dogs in the class may be handled by the owner or any other person and may be entered in additional class or classes.

The Wild Card R/R classes will be performed in the same order as the regular classes (Novice, Open, Utility) except that VERBAL PRAISE during the exercise is to be ENCOURAGED and NOT penalized. Examples of praise that would be allowed: "good, yes, nice, super, great, atta boy." Handlers will not be allowed to hold up a class with excessive encouragement and the Judge will have the option to end any exercise.

Each handler may ALSO choose to:

- SKIP ONE EXERCISE or
- Choose to do that exercise but be allowed to leave their position anytime during that exercise and go to the dog to reward with a TOY (The toy must fit in a pocket or be concealed under clothing, not visible to the dog. TOY MAY NOT MAKE NOISE NOR ROLL INTO ANOTHER RING!).

When checking in, the HANDLER MUST INFORM THE JUDGE OR STEWARD which exercise selected to SKIP or selected to GO AND REWARD the dog.!

WILD CARD RANDOM REWARD is for FUN and practice! No TITLES are earned.

HOW TO SEND IN AN ENTRY

ENTRY PREPARATION OPTION 1: The preferred entry preparation option uses the Entry form formatted as pdf. fillable forms. Tab from box to box, and enter the text, or click on the small box to complete the forms. In the top section of the Entry form click on the box(es) next to the class(es) you wish to enter in each trial. Enter the jump height in the next column where needed. Then enter the entry fee in the box to the right of the jump height box. Put the total entry fee for each trial at the bottom of the entry fee column. In the bottom row enter the total entry fee for all trials. Put the total amount submitted in the last box on the right. Enter the dog's information and the owner's information in the lower boxes. Be sure to include REGISTRATION NUMBERS, the DOG'S OFFICIAL NAME, GENDER and BIRTHDATE. Input your name in the signature boxes on both forms. There is no need to fill anything out by hand.

ENTRY PREPARATION OPTION 2: The Entry form and Waiver may be filled out by hand. The form is filled the same way as the Option 1 forms, except boxes are checked, and the text is handwritten. Last, sign at the bottom. If any information on handscribed forms is illegible, the entry will not be processed, and the handler will be requested to redo the entry using the fillable form or email the information. The Agreement form only requires entering the owner's name, telephone number, email address and another signature.

ENTRY FEE PAYMENTS: You may pay the entry fees either by check or using Paypal. See the instructions on page 3 above.

ENTRY SUBMISSION: There are likewise two ways to submit entry forms to the Trial Secretary.

- Electronic Copy Submission—Electronic submission of the Entry is the preferable option. After filling out the entry form, save the last 2 pages of the premium as a separate pdf document. Attach to an email sent to dtcttrialsec@outlook.com. Please no photographs.
- Paper Copy Submission—You may snail mail paper copies of the completed Entry and Waiver to the Trial Secretary at

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
