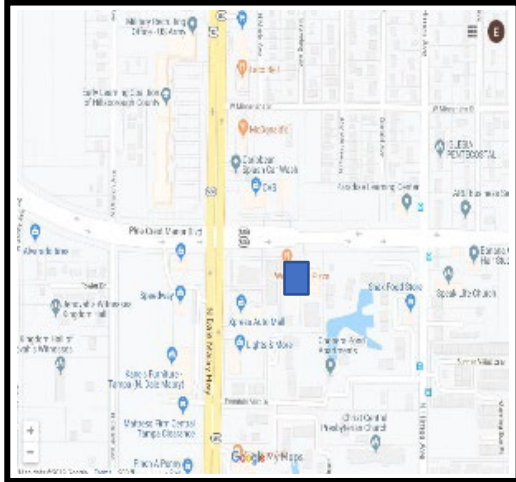

## NOTICES TO EXHIBITORS

**Entry Fees**—Online entry fees paid using Paypal are higher than entry fees paid by check because the online fees include the Paypal charge to the Club.

Single entry of dog in regular class each trial	\$32
Double entry of same dog in two regular classes in the same trial	\$55 (\$32+\$23)
Triple entry (rally master, rally excellent, rally advanced) of same dog in the same trial.	\$75 (\$32+\$23+\$20)
Quad entry (rally choice, rally master, rally excellent, rally advanced) of same dog in the same trial	\$95 (\$32+\$23+\$20+\$20)

- **Payment by Check**-- Entry fees may be paid by check. Checks should be made out to “DTCT” and mailed to the Trial Secretary along with the entry form. Checks will be deposited immediately after the trial closing date.
- **Paypal Payments**-- Electronic submission of payments is also available using Paypal and the fillable Entry form. You must use your personal Paypal account. Open the account, click the “Send” button, enter [DTCTampa@yahoo.com](mailto:DTCTampa@yahoo.com) in the box and follow the prompts from there. **Please indicate in the notes section that the payment is for the April trial entry fees. Proof of payment is required for Paypal online entries to be processed.**
- **AKC Recording Fees:** Per AKC, a recording fee of \$3.50 will be required for each dog’s entry in a trial.. **The recording fee is included in the trial entry fees.**
- **Refunds:** Entry fees will not be refunded in the event a dog is absent, disqualified, or excused by the judge or veterinarian, or barred from competition by the trial committee. If riots, civil disturbances, weather or other acts beyond the control of the club make it impossible to open or complete the trial, no refund of entry fees will be granted

- **The pdf. format fillable Entry form** is found on page 4 of this premium Please see the directions on page 3 explaining how to use this form. Entries can also be handwritten.
- **Closing Date:** Entries close at **6:00 P.M on March 21, 2025**, after which time entries cannot be accepted, changed, or cancelled as provided in Chapter 11, Section 6 of the Dog Show Rules. All overnight entries must be marked “Signature Waived.” **No entries will be accepted, cancelled, or changed after the closing date.** The exception is for bitches that come in season after the closing.
- **Transfers (moveups):** Transfers for the Saturday, April 5, 2025, trials must be submitted to the Trial Secretary by Monday, March 31, 2025. Transfers for the Sunday, April 6, 2025, trials must be submitted to the Trial Secretary by the close of Saturday’s trials. Same trial day transfers are not allowed. Contact or see the Trial Secretary for transfer forms.
- DTCT is committed to holding these trials contingent on compliance with governmental regulations and with cautious regard to everyone's health and safety. Masking is currently optional inside the DTCT building. We Keep our mask policies up to date and will continue to do so according to CDC recommendations for Hillsborough County’s current level of transmission.
- **Judging Limits**—Judging shall be limited to 8 hours per day including bathroom and meal breaks. Classes are limited to 12 dogs; entries received after the limits are reached will be placed on a waiting list.

### TRIAL SITE

- There is no room for RV’s on the trial site. Overnight parking is NOT allowed.
- The building will be air conditioned for the dogs’ comfort.
- Lunch will be available on the premises for a \$5 donation.
- Dogs should be present not more than ½ hour prior to judging and will be expected to leave immediately after the class unless needed for further judging.
- 
- Due to space constraints, unentered dogs and X-pens are not allowed on the premises during the Trials.

- Crates and chairs cannot be placed directly on the ring matting. Please bring your own mat if you wish to use the designated crating area.

### **RALLY EXHIBITORS**

If your Rally class requires a jump height because the class will be ordered by jump height, you **MUST** supply a jump height on your entry form, or the trial secretary will not accept your entry. The Trial Secretary will not contact you for this information.

- Rally jump heights for Saturday will be 16"- 4" and Sunday, 4"- 16".
- **You are expected to understand the Rally Rules and understand which Rally class "A" or "B" at any level to enter. The rules differ between the Rally Novice class, Intermediate and Advanced/Excellent, Master and Choice classes. Be advised that your leg will not count if you earn it in the wrong class! ### **HOW TO SEND IN AN ENTRY**

**ENTRY PREPARATION OPTION 1:** The preferred entry preparation option uses the Entry and Waiver forms formatted as pdf. fillable forms. Tab from box to box, and enter the text, or click on the small box to complete the forms. In the top section of the Entry form click on the box(es) next to the class(es) you wish to enter in each trial. Enter the jump height in the next column where needed. Then enter the entry fee in the box to the right of the jump height box. Put the total entry fee for each trial at the bottom of the entry fee column. In the bottom row enter the total entry fee for all trials. Put the total amount submitted in the last box on the right. Enter the dog's information and the owner's information in the lower boxes. Be sure to include **REGISTRATION NUMBERS, the DOG'S OFFICIAL NAME, GENDER and BIRTHDATE**. Input your name in the signature boxes on both forms. There is no need to fill anything out by hand.

**ENTRY PREPARATION OPTION 2:** The Entry form may be filled out by hand. The form is filled the same way as the Option 1 forms, except boxes are checked, and the text is handwritten. Last, sign at the bottom. **If any information on handscribed forms is illegible, the**

**entry will not be processed, and the handler will be requested to redo the entry** using the fillable form or email the information. The Agreement form only requires entering the owner's name, telephone number, email address and another signature.

**ENTRY SUBMISSION:** There are two ways to submit entry forms to the Trial Secretary.

- **Electronic Copy Submission**—To submit the entry form electronically , save the last 2 pages of the premium as a separate pdf document. Attach to an email sent to [dtcttrialsec@outlook.com](mailto:dtcttrialsec@outlook.com). Please no photographs or screenshots of entry forms.
